**The appointment of the candidate shall be subject to the following conditions:**

01. The appointee his directed to report Principal, Government Medical College, Doda within 21 days after the date of issuance of this appointment order along with all the original certificates, two photocopies of all educational and other concerned certificates.  
The appointee shall be allowed to join only on production of the following certificates in original:
  - i. Date of birth certificate
  - ii. Qualification certificate
  - iii. Permanent resident certificate issued by the competent authority.
  - iv. Health certificate
  - v. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
  - vi. Relevant category certificate, where applicable.
  - vii. Any other documents as required under rules.
02. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the inspector General of Police (CID), J&K to whom a reference shall be made by this office, the candidate shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
03. The appointment of candidate is subject to verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
04. The salary of the appointee shall not be drawn and disbursed to them unless the satisfactory report in respect of (01) and (02) above are received in their favour.


05. The appointment of the candidate shall be governed by *SRO-202 of 2015 dated 30-06-2015*.
