Pursuant to the Administrative Department's letter No: ME/NG/New/GMC/03/2019-PF dated 18-03-2020 and the recommendations of the J&K Service Selection Board, Jammu vide No. SSB/Secy/Sel/J/36/2020/1960-66 dated 11-03-2020, sanction is hereby accorded to the temporary appointment of 01 candidate as per *Annexure I* to this order against the post of "Technical Assistant/Technician Ophthalmology" in the Govt. Medical College Doda, Divisional Cadre Jammu in the pay band of PB-1(5200-20200) with grade pay of Rs.2400 (Pre revised) now revised to Level 4 (25500-81100) with immediate effect.

The appointment of the candidate shall be subject to the following conditions:

01. The appointee are directed to report Principal, Government Medical College, Doda within 21 days after the date of issuance of this appointment order along with all the original certificates, two photocopies of all educational and other concerned certificates. The appointees shall be allowed to join only on production of the following certificates in original:
 - i. Date of birth certificate
 - ii. Qualification certificate
 - iii. Permanent resident certificate issued by the competent authority.
 - iv. Health certificate
 - v. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
 - vi. Relevant category certificate, where applicable.
 - vii. Any other documents as required under rules.
02. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the inspector General of Police (CID), J&K to whom a reference shall be made by this office, the candidate shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
03. The appointment of candidate is subject to verification/genuineness of the qualification certificate and the reserved category certificates from the concerned issuing authorities.

07. The appointment in Divisional cadre is not transferable from one Division to another or from one Medical College to another.
08. The appointment of the selected candidate shall further be subject to outcome of writ petitioner(s), if any, pending on the subject in any court of competent jurisdiction.
09. The inter-seniority of the above appointee shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.

The candidate who have failed to join this office within the stipulated time period of 21 days forego his/her right of appointment which shall be deemed to have been cancelled ab-initio without any further notice as per the instructions issued by the Gen. Administration Department vide circular No.08-JK(GAD) of 2019 dated 04-12-2019.




