**The selection is strictly governed by the following Terms and Conditions:**

1. The above selection of candidates is under ECRP under NHM is provisional and subjected to the production and verification of all requisite original documents.

2. All the selected candidates are advised to join in the office of Principal Govt. Medical College Doda, within 7 days after the issuance of this order.
3. The monthly remuneration of the hired candidates shall be released under National Health Mission only after the verification of their all documents from the concerned quarters.
4. Candidates who fails to bring the original certificates at the time of joining or found false will not be allowed to join.
5. The candidates are selected on contractual basis for COVID purpose duties only.
6. The contractual appointee shall have to furnish an affidavit to the extent that they will not claim regular appointment on the post of GMC Doda and AH GMC Doda at any future date on the strength of the contractual appointment.
7. The contractual selection shall be terminable on one month prior notice from either side or on payment of one month salary in lieu of notice by the appointing authority.
8. If the contractual appointee at any point of time willfully neglects or refuses to perform his/her duties, the Appointing authority shall immediately terminate his/her contractual appointment without any notice and he/she shall not be entitled to any salary for such period.
9. In case of poor performance, services of the candidates are liable to be terminated without any prior notice.

The candidates shall be allowed to join only after the verification of the following documents in original and 3 set of self attested photocopies along with 03 file covers at the time of joining.
