The engagement of the above mentioned Demonstrator/Senior-Resident/Registrar shall, however, be subject to the following terms and conditions:

1. These **Demonstrator/Senior-Resident/Registrar** are directed to report Principal, Government Medical College, Doda within **07 days** after the date of issuance of this order along with the valid certificates and requisite Degree.
2. The tenure of **Demonstrator/Senior-Resident/Registrar** shall be subject to work and conduct of the Registrar in the Associated Hospital, Govt. Medical College, Doda remaining satisfactory during their tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital services/patient care, the tenure appointment of doctors shall be terminated without any notice.
3. These **Demonstrator/Senior-Resident/Registrar** shall be whole timer and shall not engage him/herself in private practice. In case of these doctors found resorting to private practice their tenure of appointment will be terminated without any notice and disciplinary action will be taken against them.
4. These **Demonstrator/Senior-Resident/Registrar** shall be required to stay in the College/Hospital premises if residential accommodation is available.
5. These **Demonstrator/Senior-Resident/Registrar** shall be liable to be transferred from the College even during the period of Registrar ship/ Senior Resident Ship if his/her services are require elsewhere in the public interest.

6. No **Demonstrator/Senior-Resident/Registrar** appointed under this order shall be allowed to apply for any job during the tenure of Registrar ship/Senior Resident ship nor shall the controlling authority forward any such application to the concerned quarter if any forwarded by their parent department after shaking up job of the Registrar/Senior Resident shall be treated as cancelled.
7. These **Demonstrator/Senior-Resident/Registrar** shall be asked to give and undertaking to the effect that they have read the aforesaid terms and conditions and shall abide by the same on an affidavit duly attested by the Magistrate before they are allowed to join. They shall submit their joining report to the Principal, Government Medical College, Doda only after a formal letter is sent to them after ensuring that all the requisite formalities have been completed.
8. These **Demonstrator/Senior-Resident/Registrar** shall have to reside within or near College Campus.
9. Any **Demonstrator/Senior-Resident/Registrar** intending to leave the job shall have to provide one month's prior notice duly forwarded by the concerned HOD or else the Doctor shall have to deposit one month's salary in this institution, Further, one month's salary of appointees shall be kept withheld as security.
10. No experience certificate will be issued before completion of tenure of one year.
11. The above engagements shall be without prejudice to the outcome of Writ Petition(s), if any, pending consideration before the Court(s) the of competent jurisdiction.
