Consequent upon the final merit list framed in GMC Doda against to the Advertisement Notice No; 134 of GMCD of 2020 dated 15.06.2020, following candidates as per Annexure-I have been selected for the post of Lab. Technician.

The appointment of these candidates shall be subject to the following conditions:

01. The appointees are directed to report Principal, Government Medical College, Doda within 07 days after the date of issuance of this appointment order along with all the original certificates, two photocopies of all educational and other concerned certificates.

The appointees shall be allowed to join only on production of the following certificates in original:

- i. Date of birth certificate
- ii. Qualification certificate
- iii. Permanent resident certificate/Domicile Certificate issued by the competent authority.
- iv. Health certificate
- v. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
- vi. Any other documents as required under rules.

02. The above engagement is academic arrangement basis initially for a period of Six (06) months extendable upto maximum of one year (subject to good performance and conduct).
03. The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment under normal process of selection/ appointment;
04. The services of an appointee under these rules shall be terminable before the expiry of the tenure of appointment with one month's notice, from either side, or on payment of one month's salary in lieu of notice by the appointing authority.
05. The appointee under these rules shall have to execute an agreement with the Department in terms of SRO-24 of 2019.
06. The appointee shall be entitled to a casual leave of 15 days for the period of one year. Any leave beyond that period, on whatever ground it may be, shall be at the discretion of the appointing authority on justified grounds.

07. The appointee at any time willfully neglects or refuses to perform his/ her duties, the appointing authority shall immediately terminate his/her appointment on academic arrangement basis without any notice and he/she shall not be entitled to any salary for such period.
08. The above engagement shall be without prejudice to the outcome of Writ Petition(s), if any, pending consideration before the Court(s) of the competent jurisdiction.
09. The candidates who have fail to join this office within the stipulated time period of 07 days forego his/ her right of appointment which shall be deemed to have been cancelled *ab-initio* without any further notice.


