 **The selection is strictly governed by the following Terms and Conditions:**

1. The above selection of candidate is in Addiction Treatment Facility (ATF) under National Drug Dependence Treatment Centre (NDDTC) is provisional and subjected to the production and verification of all requisite original documents.
2. The selected candidate is advised to join in the office of Principal Govt. Medical College Doda, within 21 days after the issuance of this order.
3. The monthly remuneration of the hired candidates shall be released under National Drug Dependence Treatment Centre (NDDTC), New Delhi only after the verification of their all documents from the concerned quarters.
4. If the candidate fails to bring the original certificates at the time of joining or found false will not be allowed to join.
5. The contractual appointee shall have to furnish an affidavit to the extent that they will not claim regular appointment on the post of GMC Doda and AH GMC Doda at any future date on the strength of the contractual appointment.
6. The contractual selection shall be terminable on one month prior notice from either side or on payment of one month salary in lieu of notice by the appointing authority.
7. If the contractual appointee at any point of time wilfully neglects or refuses to perform his/her duties, the Appointing authority shall immediately terminate his/her contractual appointment without any notice and he/she shall not be entitled to any salary for such period.

8. In case of poor performance, services of the candidates are liable to be terminated without any prior notice.

The candidate shall be allowed to join only after the verification of the following documents in original and 3 set of self attested photocopies along with 03 file covers at the time of joining.

1. Academic/Technical Qualification Certificate.

3. Health Certificate from the concerned Chief Medical Officer of the District.
