



Sub: Allotment of Car Parking in Associated Hospital of Government Medical College
Doda

(ORDER)

Whereas this office issued Auction Notice bearing No: GMCD/Auc/2019-20/126-130 dated 12-09-2019 regarding allotment of annual contracts by open auction for the year 2019-20,

Whereas the said Car Parking Auction took place on 26th September, 2019 at 11.00 am in presence of the members of Auction Committee and Chairman Auction Committee,

Whereas the highest successful bidder was declared M/S Shahdab Sharwady R/O Doda whose highest bid was @ Rs.5,50,000/- and accordingly vide this office notification No: GMCD/Auc/Plg/2019-20/280-86 dated 28-09-20-19 the said successful bidder was asked to deposit the bidding amount in the account head of Chief Accounts Officer, GMC Doda up to 1st October, 2019,

Whereas the said contractor failed to deposit the required amount within the stipulated period and instead has requested for withdrawal of his name from the bid candidature,

Whereas Auction Committee which met on 12-10-2019 under the Chairmanship of Principal/dean, GMC Doda decided that the 2nd highest bidder namely M/S Ubaid Balwan R/O Asthan Mohalla Doda who offered Rs.2,04,500/- shall be given chance to negotiate with the committee as there was lot of difference between first and second bidder. The concerned firm met with the constituted Auction Committee in the office chambers of Principal, GMC Doda on 12-10-2019 for the negotiation.


Whereas after hectic negotiation, the concerned firm accepted to raise the bid amount from Rs.2,04,500/- to Rs. 3,00,000/- which was unanimously accepted and approved by the Auction Committee, and the concerned firm was accordingly directed to deposit the bid amount amounting to Rs.3.00 lakhs (Three lakhs only) in the Account of Hospital Development Fund maintained by the Medical Superintendent, Associated Hospital GMC Doda,

Now after completing all the requisite formalities and amount deposited by the firm in the HDF account of Medical Superintendent Associated Hospital GMC Doda, the Car Parking allotment is hereby made in favour of M/S Ubaid Balwan S/O Asgar Ali Balwan R/O Astan Mohalla Doda on the following terms and conditions :-

TERMS AND CONDITIONS:

1. The contract is purely for one year extendable up to two years subject to the performance and reviewing by the Auction Committee,
2. The bidder has to charge @ Rs.20/= per car,)
@Rs.10/- per motor cycle/scooty and) for minimum
@Rs.50/- per heavy vehicle) two hours
3. Night haltage for heavy vehicle @Rs.100/- and for Car & Motor bike @ Rs.50/- and Rs.30/- respectively,
4. Rs. 1000/- per month for Cars and Rs. 750/- per month for Motor Cycles.

5. Entry fee of Rs. 10/- shall be charged to all two wheelers and four wheelers for trespassing the hospital premises once in a day entering into the hospital premises,
6. Vehicles of GMC, Doda employees registered with the bidder shall be exempted from parking charges only during official hours and also for those officials who are on emergency duty as per duty roster/on call duty roster.
7. Parking of heavy vehicles is not permissible or allowed on monthly basis,
8. Officers and officials of GMC Doda and Associated Hospital shall park their vehicles only in a specified place as designated by the administration,
9. The designated place for public car parking is from Gate No: 01 to Gate No: 02 and other remaining areas belonging to the Associated Hospital GMC Doda.
