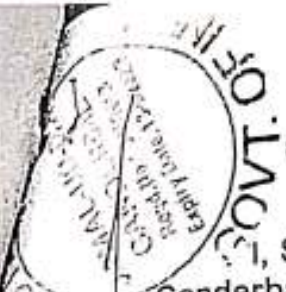




Parents specific Undertaking

1. During the Admission process of my son, as a Parent, I have already been explained the rules of discipline and conduct of my son / daughter in the Govt. Medical College Doda and I have understood the same fully.
2. As a Parent, I do hereby undertake to promptly pay the hostel dues well before the due date notified. I am aware that my son / daughter is liable to be sent out of the Hostel for non- payment of Hostel dues without prior notice and other charge for breakage or damage etc.
3.
