## Terms and Conditions:

1. The applicant must be a Domicile of Jammu Division of Union Territory of J&K.

 Interested persons may apply by sending their application on prescribed format attached herewith. The duly filled application form along with testimonials self attested and one recent passport size photograph must be submitted in the office of the Principal Govt. Medical College, Doda by hand or post before 16<sup>th</sup> of August 2021. No application form for through e-mail shall be entertained.

3. No application form received through post after 16<sup>th</sup> of august 2021 shall be entertained even if it would have been dispatched before the due date. As such the candidates who will send the application form by post shall dispatch it at the earliest so that the application form through post does not delay. In case of any delay by post the responsibility for delay shall lie with the applicant concerned.

4. The hiring of staff for above said posts is purely on contractual basis initially for a period of one year and extendable upto three years based upon performance or until the said post may be filled on permanent basis or by promotional quota whichever is earlier.

In case of unsatisfactory performance, the appointing authority shall have the right to terminate the hiring without assigning any reason.

6. A contractual appointee shall not be entitled to any preferential claim for regular

appointment under normal process of selection.

7. The candidate who have obtained degrees through Distance Education Mode from university recognized by the UGC, as mentioned in Govt. Order No: 252-HME of 2012 dated: 30-05-2012 issued by the Higher Education Department Civil Secretariat, J&K after 2005 shall have to submit a certificate from the concerned university along with application form stating that candidate had undergone the degree from their university head quarters and not from the off- campuses which have been established by these universities beyond their territorial jurisdiction. Application shall not be accepted in absence of this certificate.

8. The engagement is purely for Govt. Medical College, Doda and non transferrable to any

other health institution.

Application can be rejected by the screening Committee if found not falling in the required criteria.

The appointing authority has a right to disengage the appointee at any time.

The number of vacancies is only indicative and may increase or decrease.
