3. Permanent resident certificate issued by the competent authority.
4. Health certificate
5. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.

6. Relevant category certificate, where applicable.
7. Any other documents as required under rules.

The appointment of these candidates shall be subject to the following conditions:

1. Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the inspector General of Police (CID), J&K to whom a reference shall be made by this office, the candidate shall have no right claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
2. Verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
3. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (I) and (II) above are received in their favour.
4. The appointment of these candidates shall be governed by SRO-202 of 2015 dated 30-06-2015.
5. The appointees shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2019 dated 24-12-2009.
6. The appointment in Divisional cadre is not transferable from one Division to another or from one Medical College to another.
7. The appointment of the selected candidates shall further be subject to outcome of writ petitioner(s), if any, pending on the subject in any court of competent jurisdiction.
8. The inter-seniority of the above appointees shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.
