Consequent upon the approval conveyed the Administrative Department vide letter No. ME-NG/292/2021-02 dated 12-01-2022 and in reference to cancellation of appointment of candidates vide this office order issued vide order No.57-NG of 2020 dated 11-05-2020 and 135-NG of 2020 dated 15-06-2020 and 287-NG of 2020 dated 15-09-2020, the candidates next in merit list/waiting list namely Shazia Iqball Zarger D/o Mohd Iqball R/o Batt market Doda Bhalessa block Changa 903986 Bhalessa Doda, is hereby appointed against the post of "Junior Staff Nurse " in Govt. Medical College, Doda (Divisional Cadre Jammu) in the pay scale of PB-1(5200-20200) with grade pay of Rs.2400 (Pre revised) now revised to Level 4 (25500-81100) with immediate effect.

The appointment of the candidate shall be subject to the following conditions:

01. The appointee is directed to report Principal, Government Medical College, Doda within 21 days after the date of issuance of this appointment order along with all the original certificates, two photocopies of all educational and other concerned certificates.

The appointee shall be allowed to join only on production of the following certificates in original:

- i. Date of birth certificate
- ii. Qualification certificate
- iii. Domicile certificate issued by the competent authority.
- iv. Health certificate
- v. Certificate from the concerned Deputy Director, Employment and General Manager, DIC to the effect that no loan under self-employment scheme has been taken by the appointee.
- vi. Relevant category certificate, where applicable.
- vii. Any other documents as required under rules.

02. The appointment of candidate is subject to verification/genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities and in case of any adverse report received from any quarter, the appointment of the candidate shall be deemed to have been cancelled *ab-initio*.
03. The salary of the appointee shall be drawn and disbursed only after receiving satisfactory report in respect of (S.No. 02) from the concerned quarter.
04. The appointment of the candidate shall be governed by *under S.O-425 dated 06-09-2022*.
05. The appointee shall be governed by the "*New Pension Scheme*" as notified vide *SRO-400 of 2009 dated 24-12-2009*.
06. The appointment in Divisional cadre is not transferable from one Division to another or from one Medical College to another.
07. The appointment of the selected candidate shall further be subject to outcome of writ petitioner(s), if any, pending on the subject in any court of competent jurisdiction.
08. The inter-seniority of the above appointee shall be as per the merit secured by them in the selection process as indicated against each in the select list furnished by the J&K Services Selection Board.
09. The candidate who fails to join this office within the stipulated time period of 21 days forego their right of appointment which shall be deemed to have been cancelled *ab-initio* without any further notice as per the instructions issued by the Gen. Administration Department vide circular No.08-JK(GAD) of 2019 dated 04-12-2019.
